WHEREAS, Declarant annexed and added Normandy Forest Section Five to the property governed by the Declaration by the Fourth Supplemental Declaration of Covenants, Conditions and Restrictions, Normandy Forest, Section Five, in accordance with Article IX, Section 7 of the Declaration, such Supplemental Declaration being recorded under County Clerk's File No. U465597 of the Official Public Records of Real Property of Harris County, Texas; and

WHEREAS, Declarant is the owner of that certain 19.580 acres of land and improvements, being all of Normandy Forest Section Six, as designated on the plat of Normandy Forest, Section Six, recorded under County Clerk's File No. V849698 of the Official Public Records of Real Property of Harris County, Texas, containing seventy-seven (77) lots; and

WHEREAS, Declarant annexed and added Normandy Forest Section Six to the property governed by the Declaration by the Fifth Supplemental Declaration of Covenants, Conditions and Restrictions, Normandy Forest, Section Six, in accordance with Article IX, Section 7 of the Declaration, such Supplemental Declaration being recorded under County Clerk's File No. V869977 of the Official Public Records of Real Property of Harris County, Texas; and

WHEREAS, Declarant is the owner of that certain 15.941 acres of land and improvements (hereinafter called the "Additional Land"), being all of Normandy Forest Section Seven,

as designated on the plat of Normandy Forest, Section Seven, recorded under County Clerk's File No. W841595 of the Official Public Records of Real Property of Harris County, Texas, containing sixty-two (62) lots; and

WHEREAS, Declarant desires to annex and add the Additional Land to the property governed by the Declaration by this Supplemental Declaration in accordance with Article IX, Section 7 of the Declaration;

NOW, THEREFORE, as provided by the Declaration, and in order to create and carry out a uniform plan for the improvement, development, sale and use of Lots in the Subdivision for the benefit of the present and future Owners of the Lots, Declarant does hereby submit this Sixth Supplemental Declaration as follows:

1. The Declaration is hereby supplemented and amended to include, as a part of the property governed thereby, the Additional Land, and Declarant hereby declares that the property contained therein shall be held, conveyed, mortgaged, encumbered, leased, rented, used, occupied, sold and improved subject to the declarations, limitations, covenants, conditions, restrictions and easements set forth in the Declaration.

Except as expressly amended by this Sixth Supplemental Declaration, all of the terms, covenants, conditions and restrictions of the Declaration, and the First, Second, Third, Fourth and Fifth Supplement Declarations shall remain in full force and effect.
